

1) Fundamental Course I (JLPT: N5 Part I)

(On First come first serve basis) This course is specially designed for the participants who have not studied Japanese language. During the course, the learners will be taught how to use the Japanese language in everyday life. Reading and Writing of 3 kinds of Japanese script i.e., Hiragana, Katakana, around 50 Kanji (Chinese characters) will be taught, along with this 400 words will also be introduced, through our special Easy Learning Teaching Methodology that makes the language easy to learn in an effective manner, this Methodology is developed by our Japanese language experts. The learners will have the ability to engage in simple conversation and to read and write, basic sentences in Japanese.

3) Intermediate Course I (JLPT: N4 Part I)

(Entrance Test is compulsory or JLPT Level 4 or N5 certificate) This course is for the learners who have already passed Japanese Language Proficiency Test (JLPT) Level 4 /N5, or have knowledge of Japanese language, equivalent to the same. After completing this course, the students will be able to converse with the Japanese people about their lifestyle, ideas, and also can exchange basic information about Japan and India and tackle elementary problems that foreigners may face in Japan. During the course, 150 Kanji and approximately 400 words will be taught.

4) Intermediate Course II (JLPT: N4 Part II)

(Entrance Test is compulsory or Basic Course certificate by NIC JLSC) After completing the Intermediate Course, this course will focus on JLPT N4 which includes grammar to a limited level, around 300 Kanji and 1500 words. 5. ACADEMIC STRUCTURE :

5.1 ADMISSION AND REGISTRATION :

- An applicant for admission to a programme must apply in the prescribed Application Form following the Advertisement in Newspapers, Websites, Local Cable TV, Display Boards etc.
- The selection for admission of candidates will be done through Common Admission Test, Personal Interview and on the basis of Marks Obtained in the School examination. There are certain skills training programmes in which admission eligibility will depend on the pass percentage marks of the qualifying examination and / or Trade Test.
- A student seeking admission must be medically fit.
- Provisional Registration may be granted on spot admission subject to verification of documents for his / her eligibility to join a training module.
- Final Registration shall be normally allowed in 15 days after due verification of eligibility.

5.2 TRAINING GUIDELINES :

Training needs are identified and discussed before Training Module is designed.

- Training is provided mostly free of cost.
- Regular attendance is required during the course of Training.
- Normally Training period is about six month, but in some cases it may be flexible.
- For serious and regular candidates, Training should normally result in gainful employment whether inland or overseas depending on successful acquisition of skills by an Individual.
- Industry visit and Hands-on Practical Training will be arranged during the training period.

5.3 EXAMINATION, EVALUATION & CERTIFICATION : :

- We are following a 5-point Grading System of evaluation from the year 2022-2023, i.e. using the letters A, B, C, D and F, with indication as A for Excellent, B for Good, C for Average, D for Fair and F for Fail.
- ✤ The EXAMINATIONS norm includes continuous monitoring and evaluation of performance of the students which includes KNOWLEDGE (40 %) and SKILLS (60 %) BASED COMPETENCIES EVALUATION / ASSESSMENT.
- Separate Tests for Knowledge (Theory Based) and Skills (Practice Based).
- The SSC or authorized Industry /Agency is involved for rigorous domain Tests as per the well defined Job
 Role / QP / NOS for competencies evaluation and certification.
- Without proper attendance during training, a candidate is not allowed / eligible to undergo Test.

5.4 EMPLOYMENT

- Employment is a process (On-campus & Off-campus) which would normally begin after ASSESSMENT / CERTIFICATION by inviting prospective Employer (s) from India and abroad for which the candidate should be in touch with the Director (Placement).
- ✤ TTC EXPOSURE IS OF GOOD HELP IN CONFIDENCE BUILDING.
- NIC shall assist in arranging employment of its pass out candidates in accordance with the merit of the candidate for which applications will have to be submitted to Placement Cell in time.
